# MINUTES CARDINGTON PARISH COUNCIL MEETING HELD ON

#### 1. Public Session. Limited to 15 minutes

The member of the public present did not wish to comment.

#### 2. Acceptance of Apologies

Apologies were accepted from C'llr V Rogers

#### 3. Declarations of Interest

No declarations of interest were received.

#### 4. Minutes of meeting held on Tuesday 3<sup>rd</sup> September 2019

It was proposed by C'llr Pennington, seconded by C'llr Seabury and unanimously agreed that the Minutes of the meeting held on 3<sup>rd</sup> September provided a true and accurate records of the meeting.

#### 5. Correspondence

The Clerk reported the following correspondence:-

- West Mercia Police Rural Crime Strategy Consultation. Forwarded to all Parish Councillors on 24<sup>th</sup> October. Consultation closes 8<sup>th</sup> November.
- Shropshire Council Library Strategy Consultation. Forwarded to all Parish Councillors on 22nd October. Stage 1 consultation closes 10<sup>th</sup> November. Stage 2 will be a more formal consultation after updating information from Stage 1. The Strategy document is likely to start in early 2020.
- Highways Winter Service Plan. Copy of Presentation forwarded to all Councillors on 22<sup>nd</sup> October.
- Temporary road closure, Ludlow Road, Little Stretton, from 4<sup>th</sup> November 22<sup>nd</sup> November for works by Western Power. Forwarded to all Councillors on 17<sup>th</sup> October.
- E mail forwarded to all Councillors on 17<sup>th</sup> October from Pageant master encouraging local councils to take part in the "Nation's Toast to the Heroes of WW2 and ringing church bells as part of the nationwide "Ringing Out For Peace" on 8<sup>th</sup> May 2020. The Chairman had circulated this mail to the Church.
- Public consultation asking for accessibility to Theatre Severn and the Old Market Hall cinemas.

- The Strettons Community-Led Plan. Asking for input from Parish Councils. The Clerk agreed to circulate this to all Councillors.
- Shropshire Council Rural Strategy Workshop to be held 13<sup>th</sup> November 10.45am 1pm in the Council Chamber at the Shirehall.

#### 6. Phone Kiosk update

C'llr McMillan told the meeting that the artwork had gone to the printer and would hopefully be ready for collection later in the week. The cost was likely to be £105 plus vat C'llr McMillan circulated details of the information boards which include the history of Cardington, links to the Parish Council web site, the village

web site, the war dead memorial and guided walks over the Caradoc. A member of the public had given a lot of her time to prepare the boards. When the boards have been erected it was agreed that a letter of thanks would be sent. Mr Noblet would be invited to help to erect the Boards.

#### 7. Planning:

#### a. Decisions on previously discussed applications:

- 19/03216/AGR Court Farm Erection of a general purpose agricultural building sent to Parish Council for notification only.19/02201/FUL Gutter Farm, Wall Under Heywood. Approved 6.9.19
- 19/03795/TPA Brook House, Cardington fell 2 No Cherry and 1 No conifer within conservation area. Consent given 16.9.19
- 19/03805/FUL Proposed holiday park, Gretton Mill Stackyard. Application withdrawn 7.10.19.

#### b. Any other planning matters including new applications received just before the meeting

- 19/04598/TCA The Fold, Cardington fell 1No Apple tree, pollard 1 No. Apple Tree and remove 3 overhanding branches within Conservation Area circulated to all Councillors 17.10.19
- Planning Enforcement Notice. Middle Hill Farm, Cardington. Breach of Planning Control in relation to Condition 2 attached to planning permission 18/03187/AGR. Forwarded to all Councillors 26<sup>th</sup> September.

#### 8. Highways

#### a. Environmental Maintenance Grant.

As reported at the September meeting the Parish Council have received £1,250 Environmental Maintenance Grant from Shropshire and have to match any funding spent and provide copies of invoices to Shropshire Council. It was agreed that C'llr Norris would arrange for this work to be carried out to a maximum budget of £2,500.

#### b. Progress on Highway Matters reported

It is understood that the repairs to the footbridge will be carried out and Shropshire Council have now designed a scheme for the works and the order will be placed with the County's contractors and hopefully work will commence. .

#### c. Any further highway matter to report

Heavy rain had resulted in serious flooding in the parish. The pub was affected and Shropshire Council had responded to reports. Shropshire Council had provided a road sweeper to clear a deep covering of mud and debris.

It was agreed that many of the problems were caused by blocked drains being unable to take the volume of water. C'llr Roberts would be provided with a list of drains which need jetting and he will report.

C'Ilr Roberts continues to log any highway problems on the portal and receives confirmation and progress reports.

#### 9. Finance:

#### **a.** Invoices to pay:

It was proposed by C'llr Roberts, seconded by C'llr Tonks and unanimously agreed that the above accounts be paid.

The Clerk told the meeting that Mr D Hall had been paid £230 for cutting the grass at the Churchyard as agreed at the September meeting, Cheque No.100298 amounting to £230 was paid on 9<sup>th</sup> October.

#### **b.** Bank Reconciliation

The Clerk circulated a copy of the bank reconciliation which after payment of the above accounts gave a

balance held at bank of £10,665.71 which includes £1,599.16 balance of CIL money; £2,296.00 Burial Fees; £975.12 balance in Transparency Fund, £1,397.72 Parish Council carry forward from 2018/19 (the Clerk reminded the meeting that the Parish Council had to find £1,250 matched funding offered for the Highways Maintenance Grant), £1,250 Highways Maintenance Grant paid and a balance from the 2019/20 Precept of £3,147.71. The chairman then signed the Bank Statement and a copy of the bank reconciliation.

#### 10. Churchyard

C'llr Davies told the meeting that he had cleaned the war memorial the previous weekend. It was agreed that the churchyard clean up would take place on Saturday 10<sup>th</sup> November. The general clean up would be organised for Saturday 23<sup>rd</sup> November.

## 11. We Don't Buy Crime – Smartwater – Consider joining scheme – depending on response from members of the public

Households had signed up to the scheme although more households were needed to reach the 70% target to attract the grant and free signage. At least 141 households need to commit. However, it was thought that this was achievable. C'llr Tonks agreed to co-ordinate all the responses and Councillors would continue to target all areas of the parish. It was proposed by C'llr Roberts, seconded by C'llr Tonks and agreed that the Clerk would go ahead and order the kits. The Clerk was asked to clarify that any extra units ordered in the future would attract the same discount and also ask for confirmation that signs would be provided in all outlying areas of the parish.

The Parish Council contribution would be £1,073.34

C'llr McMillan also suggested that consideration should be given to placing CCTV coverage at the entrance and exit of the village.

#### 12. Shropshire Council Report.

C'llr Dan Morris reported that the next Full Council Meeting planned for 12<sup>th</sup> December had been postponed until the following week and would be held on 19<sup>th</sup> December and 20mph speed restrictions outside all schools was being considered.

C'llr Pennington told the meeting that he had attended a recent AONB meeting where targeting farmers in relation to reducing the carbon footprint was discussed. The discussion was led by Phil Holden of the AONB who wished to get the message out to farmers as to how they could help reduce the carbon footprint. It was agreed that C'llr Pennington would report back to the AONB to suggest that a presentation by the AONB could be held on a Tuesday night in the village hall in the New Year. C'llr Pennington will report back to the January meeting.
